









Revenues of Asseco Business Solutions 2022 v. 2023


Results of Asseco BS 2022 v. 2023 – by operating segments

Receipts from sales






Revenues of Asseco BS in 2023 – by sectors






Results of Asseco BS Q4 2022 v. Q4 2023






Backlog of Asseco BS at end of 2023




Costs and expenses historically (since 2020)

Dividend in 2023

- On **31 May 2023**, the Ordinary General Meeting of Shareholders of Asseco BS agreed on the amount of the dividend at: **PLN 2.30** per share.
- The dividend date was 9 June 2023, and the dividend payment date was 21 June 2023.
- The net profit of Asseco BS for the financial year 2022 totalled PLN 85,286 million, of which PLN 76,862 million was allocated for distribution among the shareholders.


